There are 62 Philippine Statistics Authority (PSA) Civil Registry System (CRS) Outlets that have been established and are now already catering to the needs of clients for PSA-issued civil registry documents and certifications. This development is part of the implementation Civil Registry System-Information Technology Project Phase II (CRS-ITP2) in line with the aim of PSA to bring its frontline services closer and more accessible to the people.

With the full implementation of CRS-ITP2, there will be a total of 81 CRS Outlets nationwide that will be able to accept and to release requests for copy issuance of birth, marriage, and death documents as well as the issuance of Certificate of No Marriage or Advisory on Marriages, and Certificate of No Death or Advisory on Deaths. These CRS Outlets shall not only be able to cater to walk-in clients but also to authorized Batch Requests System (BREQS) Partners.

In this connection and in order to lessen the distance and travel time of BREQS Partners at the Local Government Units and SM Malls in going to and from the CRS Outlet East Avenue, Quezon City for the submission and release of BREQS requests, the servicing outlets will be distributed to the nearest location as indicated in Attachment 1.

Relative thereto, BREQS Partners shall continue to upload to the CRS Website the proof of payments and encode the batch files of requests for copy issuance of civil registry documents and certifications for processing. They shall also officially delegate their authorized Liaison Officer to receive the results of verifications/documents in security paper, on the scheduled date and time of release at the designated Servicing PSA CRS Outlet.

Once the requested documents, which contain personal and sensitive information, have been released by the CRS Outlet, it is understood that it is for proper safekeeping and issuance to the rightful owner in compliance with Republic Act No. 10173 otherwise known as the Data Privacy Act of 2012. The same shall be under the responsibility and liability of the BREQS Partner.

Designation of the new servicing PSA CRS Outlet to the BREQS Partners shall take effect on **15 September 2023**.
