Series of 2019**

**APPROVING THE CREATION OF THE INTER-AGENCY COMMITTEE SUBGROUPS**

**WHEREAS**, Section 18.b of the Implementing Rules and Regulations (IRR) of RA 11055 stipulates that the PSPCC shall facilitate inter-agency cooperation and collaboration in the implementation of the PhilSys;

✧ **WHEREAS**, during the 4<sup>th</sup> PhilSys Policy and Coordination Council (PSPCC) Meeting held on 08 November 2018, it was unanimously agreed by the Member-Agencies to create an Inter-Agency Committee (IAC) to assist in the implementation of the PhilSys Identification System (PhilSys);

**WHEREAS**, the PhilSys Implementation Plan 2019-2022 identified the creation of five (5) Inter-Agency Committee (IAC) Subgroups for the purposes of the continual development of the said plan;

**NOW, THEREFORE, BE IT RESOLVED**, that the Council approves the creation of the the proposed IAC Subgroups on (1) Communications, (2) Legal Affairs, (3) Technology, (4) Registration and Validation, and (5) Use Cases and Authentication;

**RESOLVED FURTHER**, that the IAC-Communications shall support the design and implementation of the PhilSys Information and Education Campaign (IEC) to ensure sufficient awareness and approval among the public and shall be composed of the following agencies:

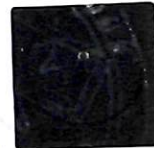
