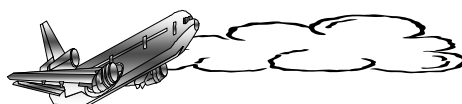

## EXPLANATORY NOTE

### Background

The National Statistics Office (NSO) has been recording the movement of commodities by port of origin and port of destination since 1968. The system used for generation of statistics was the Integrated System for Coastwise Shipping Statistics (ISCSS) revised by heads of NSO, National Economic and Development Authority (NEDA), Bureau of Customs (BC), Philippine Ports Authority (PPA), Maritime Industry Authority (MARINA) and Ministry of Public Works, Transportation and Communication (MPWTC).

On October 1, 1976 the NEDA, NSO and Philippine Airlines (PAL) agreed that PAL revised the air waybill (AWB). The project operationalized the collection and processing of data on commodities flowing through the air transport system starting September 1977.

The NEDA and NSO personnel organized a working committee with the Philippine National Railway (PNR) to improve the data system on railway statistics. This committee worked on the revision of PNR forms, "Daily Report of Waybills Forwarded" (DRWF) and the "Express/Freight Shipping Order", to make them appropriate data gathering instruments for rail trade statistics. The PNR implemented the revised DRWF in October 1977. On the following year, the system for the collection and processing of rail commodity flow statistics was operationalized.

NSO gathers information on the movement of commodity within the Philippines to enable policy-makers to monitor the domestic trade. With proper interpretation of this precious information, one may peep into the future of domestic trade and pinpoint the next growth areas in the country.

To hasten the processing and generation of domestic trade statistics, the NSO has brought the manual and computerized processing technologies to its regional (field office) and provincial offices. For this purpose, the Information Systems Development Section, Information Resources Division, developed the Domestic Trade Statistics System (DomStat). The software was designed to facilitate processing of air trade, rail trade, and coastwise cargo trade and passenger administrative documents. The DomStat is actually an integration of four systems (or subsystems) that process the different types of documents. The duration of systems development was from October 1993 to January 1994 and in January 1995 with the DomStat version 2.0. It was started and implemented in the year 1995. On the same year, the maiden publication under the DomStat system was created and 1994 DomStat data files were used. With its carefully designed user interface, the DomStat ably facilitates the generation of domestic trade statistics until the present.



In 2003, a new system was developed and introduced by the Information Resources Department - Information Technology Systems and Research Division (IRD-ITSRD) to the Industry and Trade Statistics Department - Business and Services Statistics Division (ITSD-BSSD). The new system, the DomTrade Data Processing System (DT-DPS) is a window-based application and latest enhanced version of the DOS-based DomStat system. It is designed to help the staff of NSO in the processing and generation of its Commodity Flow Statistics or commonly called the Domestic Trade Statistics.

This system covers all data processing activities of Domestic Trade from data entry, validation, completeness check, compilation, and tabulation up to maintenance of data files of previous years.

The tabulation application of the system allows generation of statistical tables in series or of different years. Printing of forms, browsing of reference files and online help are also made available by the system. Submission of data files from province can also be easily transmitted thru e-mail, which is integrated into the system.

In September to October 2003, program testing and parallel run of the DOS-based DomStat system and the DT-DPS version 1.1, were done. The National Capital Region (NCR) personnel also did pilot testing in November 2003. Business and Services Statistics Division of Industry and Trade Statistics Department utilized the new system for the generation of annual statistical tables starting with the 2004 Commodity Flow in the Philippines publication.

## **Coverage of Commodity Flow Data**

The domestic trade data contained in this report pertains to the flow of goods through airports, seaports and railway stations in the country, whether for government or private use, or for commercial purposes.

Coasting manifests were collected from major ports and other active seaports listed by the PPA all over the country. Fishing ports are excluded in the compilation of data.

Goods transported by vessels of the Philippine Navy, fish and other marine products landed direct from the sea, service cargoes for consumption of the vessel and cadaver are excluded from the data.

The air waybills were collected from the Philippine Airlines (PAL), Air Philippines and Asian Spirit operated domestic airports.

The Daily Report of Outgoing Shipments (DROS) for rail was gathered from Philippine National Railway (PNR) stations in the country.

## Items of Data Gathered

The coasting cargo manifests contain information on the following:

1. Port of origin
2. Port of destination
3. Area of occupancy
4. Type of handling
5. Description of commodity
6. Weight
7. Value
8. Freight charges

The coastwise passenger manifests contain the following information:

1. Port of origin
2. Port of destination
3. Name of passenger

The air waybill (AWB) contains the following information:

1. True destination of the commodity
2. True origin of the commodity
3. Actual gross weight \*
4. Declared value \*
5. Equivalent volume weight
6. Rate basis
7. Rate class
8. Description of commodity \*
9. Station of origin \*
10. Station of destination \*
11. Issuing office
12. PAL charges
13. Freight forwarder charges
14. Total freight charges \*

The Daily Report of Outgoing Shipments (DROS) includes the following information:

1. Station of origin
2. Station of destination
3. Description of commodity
4. Weight
5. Declared value
6. Freight or express charges

\* -- Only these variables are captured and tabulated in the Domestic Trade Statistics.

## Sources and Collection of Commodity Flow Data

The source document for coastwise trade statistics is the **Outward Coasting Manifests (Bureau of Customs Form No. 78)**, submitted by masters of vessels plying the inter-island ports to the collectors of PPA or their authorized representatives before the vessel leaves the port area. NSO personnel collect copies of these documents from the PPA designated collection points in the provinces.

Another source document is the **Philippine Coastwise Passenger Manifests (BC Form No. 460)**. Information on passengers commuting via water transport system along with the BC Form No. 78 is collected when a vessel carries both cargo and passengers. Otherwise, only one document is collected.

Data source for airway trade is the **Air Waybill (AWB), (PAL Form No. F 0777A)** issued by PAL, Asian Spirit and Air Philippines to every consignee. The acceptance and sales clerks of the airlines prepare an extra copy of every AWB issued and the corresponding sales report are collected by NSO field personnel.

The basic document used in generating the rail commodity flow statistics is the Daily Report of Outgoing Shipment (DROS), which is the summary of the daily cargoes transported through the PNR. PNR personnel from the express or freight shipping orders issued for the day copy the information contained in this form. These forms are accomplished by station agents and collected by NSO field personnel and submitted to the NSO field offices for processing.

## Processing of Commodity Flow Data

Processing of commodity flow data is done manually and by machine.

Documents collected from the provincial sales offices, stations, and collection points are sorted by port or station and by month; recorded; bundled and numbered by type of document, by port or station and by month; and undergo the following stages of processing in the field offices before transmittal to the NSO Central Office:

**Coding** is a process of assigning to an item of information a unique number called code, to simplify capturing of information and facilitate further machine processing

**Code verification** is a process of checking the validity and correctness of the code for the information given in the source document

**Computation** is a process of determining the reasonableness of the value of the commodity of specific quantity and making the necessary corrections, in case of obvious errors.

## Commodity Classification

The commodity classification used in the compilation of the data is the **1993 Philippine Standard Commodity Classification (PSCC)** which is aligned with the United Nations Standard International Trade Classification (SITC) Rev. 2.

The classification is presented in five levels of details: section, division, group, subgroup and item. A unique code number identifies each commodity. The code number of each commodity is so designed that the first digit identifies the **section**; the first two digits, the **division**; the first three digits, the **group**; the first four digits, the **sub-group**; and the five digits, the **item**.

## Geographic Classification

Domestic trade statistics are presented by geographic area. The 17 regions with the provincial composition are presented below:

**National Capital Region (NCR)** consists of the City of Manila, Quezon City, City of Mandaluyong, City of Marikina, City of Pasig, City of San Juan, Caloocan City, City of Malabon, City of Navotas, City of Valenzuela, City of Makati, Pateros, Taguig City, City of Las Piñas, City of Muntinlupa, City of Paranaque, and Pasay City

**Cordillera Administrative Region (CAR)** consists of Abra, Apayao, Benguet, Ifugao, Kalinga, and Mountain Province

**Region I (Ilocos)** consists of Ilocos Norte, Ilocos Sur, La Union, and Pangasinan

**Region II (Cagayan Valley)** consists of Batanes, Cagayan, Isabela, Nueva Vizcaya, and Quirino

**Region III (Central Luzon)** consists of Aurora, Bataan, Bulacan, Nueva Ecija, Pampanga, Tarlac, and Zambales

**Region IV-A (CALABARZON)** consists of Batangas, Cavite, Laguna, Quezon, and Rizal

**Region IV-B (MIMAROPA)** consists of Marinduque, Occidental Mindoro, Oriental Mindoro, Palawan, and Romblon

**Region V (Bicol)** consists of Albay, Camarines Norte, Camarines Sur, Catanduanes, Masbate, and Sorsogon

**Region VI (Western Visayas)** consists of Aklan, Antique, Capiz, Guimaras, Iloilo, and Negros Occidental

**Region VII (Central Visayas)** consists of Bohol, Cebu, Negros Oriental, and Siquijor

**Region VIII (Eastern Visayas)** consists of Biliran, Eastern Samar, Leyte, Northern Samar, Southern Leyte, and Western Samar

**Region IX (Zamboanga Peninsula)** consists of City of Isabela, Zamboanga City, Zamboanga del Norte, and Zamboanga del Sur

**Region X (Northern Mindanao)** consists of Bukidnon, Camiguin, Lanao del Norte, Misamis Occidental, and Misamis Oriental

**Region XI (Davao Region)** consists of Compostela Valley, Davao del Norte, Davao del Sur, and Davao Oriental

**Region XII (SOCCSKSARGEN)** consists of Cotabato City, North Cotabato, Sarangani, South Cotabato, and Sultan Kudarat

**Region XIII (Caraga)** consists of Agusan del Norte, Agusan del Sur, Dinagat Island, Surigao del Norte, and Surigao del Sur and

**Autonomous Region in Muslim Mindanao (ARMM)** consists of Basilan (except Isabela City), Lanao del Sur, Maguindanao (except Cotabato City), Shariff Kabunsuan, Sulu, and Tawi-Tawi.

## **Definition of Terms and Concepts**

**Balance of Trade** is the difference between outflow and inflow. Positive value indicates favorable trade balance while negative value indicates unfavorable trade balance

**Domestic Commodity Flow** refers to the flow of commodities through the water, air and rail transport system in the country

**Freight** refers to charges on cargoes paid for the transportation of goods for one port or station to another

**Inflow** refers to the total value of commodities coming in the specified region or province

**Outflow** refers to the total value of commodities, which flowed out of the specified region or province

**Port or Station of Origin** refers to the port or station where the cargoes came from

**Port or Station of Destination** refers to the port or station where the cargoes are destined for

**Region of Origin** refers to the regional location of the port or station where the cargoes came from

**Region of Destination** refers to regional location of the port or station where the cargoes are destined for

**Weight** represents the total volume of a commodity expressed in tons or kilograms

**Value** represents the peso equivalent of a particular commodity.

### **Availability of Data**

The **Commodity Flow in the Philippines** publication comes out three quarters after the reference year.

Quarterly special release on **Commodity Flow in the Philippines** comes out four months after the reference quarter.

Aside from the summary tables contained in the annual publication and quarterly special release, other unpublished monthly, quarterly and annual detailed tables in computer print-outs or diskette or CD are also available at the Business and Services Statistics Division, Industry and Trade Statistics Department upon request.

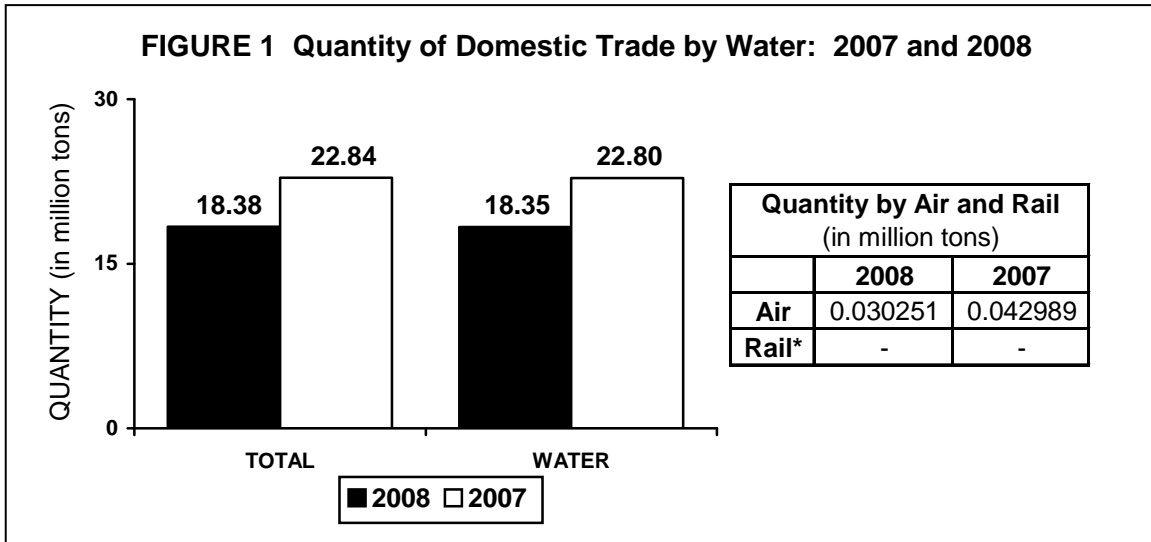
### **Limitations of the 2008 Commodity Flow in the Philippines Annual Publication:**

1. DOMSTAT reports from the following provinces or cities were not yet received as of June 30, 2009, and were not included in the statistical tables of this annual publication:
  - a. NCR – Air (February 2008)
  - b. Negros Oriental – Air (December 2008)
  - c. Cotabato City – Coastwise (January 2008)
  - d. Sulu – Coastwise (January, April, June, July, November, December 2008)  
Passenger (January – December 2008)
  - e. Tawi-Tawi – Coastwise (July, October to November 2008)  
Passenger (July, October, December)
2. There was no rail transaction from January to December 2008. The operation of the PNR was suspended.

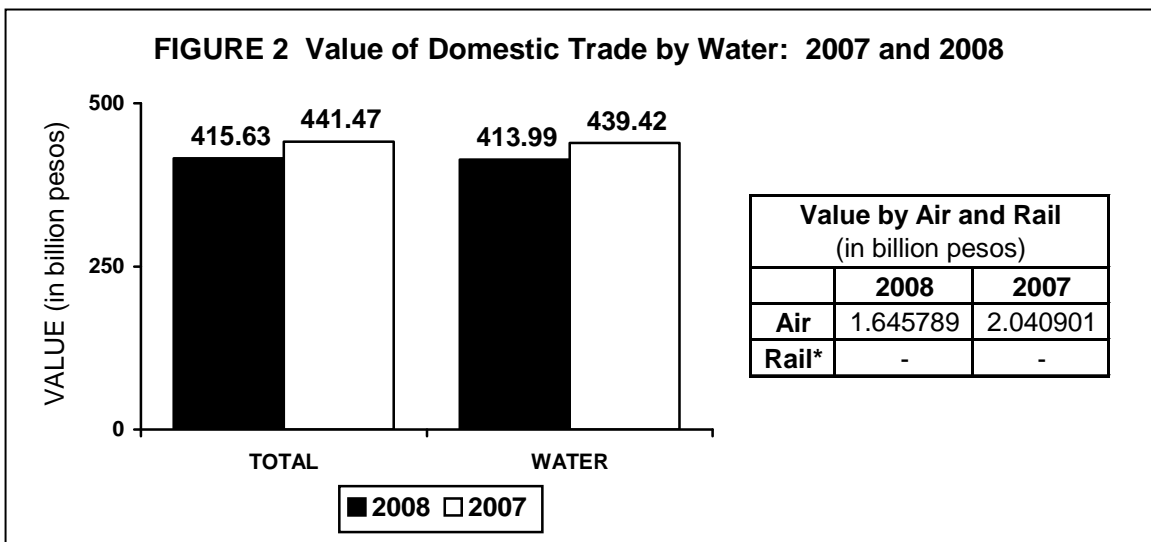
## BRIEF ANALYSIS

### Quantity and value of domestic trade decreases

The total quantity of domestic trade transactions in 2008 decreased by 19.5 percent, resulting to 18.38 million tons from 22.84 million tons reported in 2007. The commodities were traded mostly through water, comprising 99.8 percent of the total domestic trade (Figure 1).



Likewise, the total value of commodities that flowed within the country decreased by 5.9 percent, from PhP441.47 billion in 2007 to PhP415.63 billion in 2008. Shipment through water was the major mode of transport with 99.6 percent share (Figure 2).



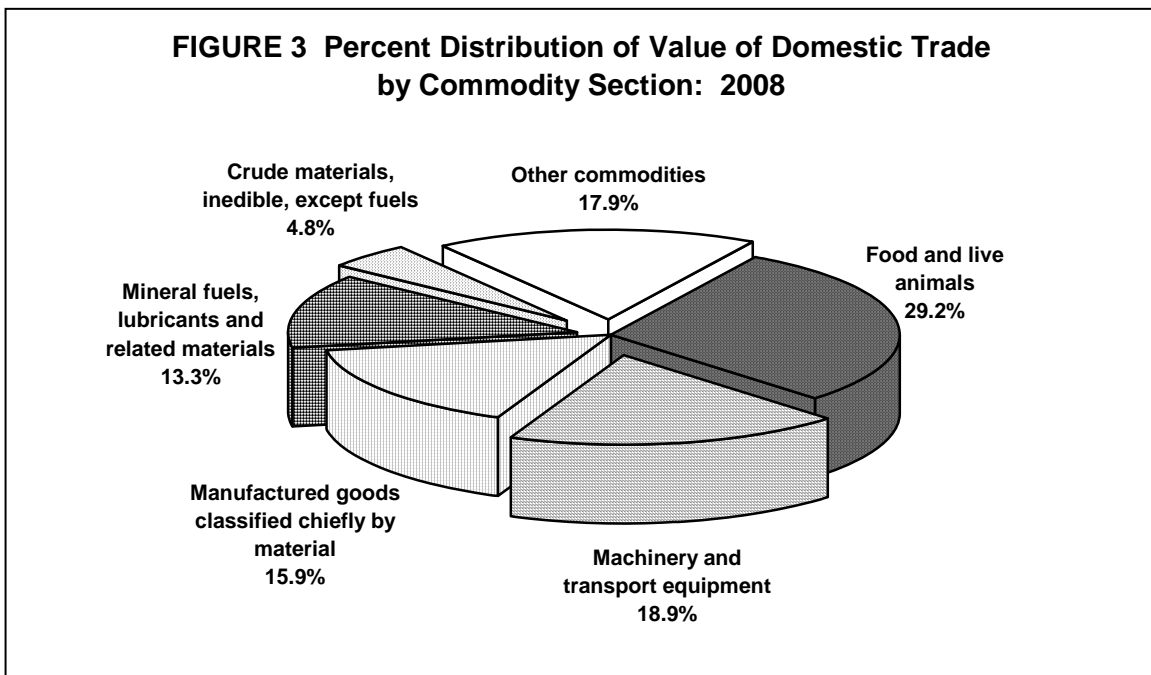
## Food and live animals dominate in total domestic trade value

Among the commodity sections that were transacted throughout the country in 2008, food and live animals contributed the largest value amounting to PhP121.27 billion (29.2%). Machinery and transport equipment was next with PhP78.46 billion (18.9%). Manufactured goods classified chiefly by material followed with PhP66.13 billion (15.9%). Animal and vegetable oils, fats and waxes shared the least value of PhP4.32 billion (1.0%) (Table A).

On the other hand, mineral fuels, lubricants and related materials topped the commodity trading in Luzon with a share of 26.9 percent (PhP48.50 billion) to the total value of commodities traded in the island group. This was followed by food and live animals with PhP33.09 billion (18.4%). Manufactured goods classified chiefly by material placed third with PhP31.40 billion (17.4%) (Table 4).

Meanwhile, the top three commodities in the Visayas, in terms of contribution to the total value of commodities traded in this island group were food and live animals, machinery and transport equipment, and manufactured goods classified chiefly by material with values PhP48.09 billion (35.8%), PhP37.62 billion (28.0%) and PhP12.12 billion (9.0%), respectively (Table 4).

Likewise, food and live animals also topped the list of commodities traded in Mindanao, contributing 39.6 percent (PhP40.10 billion) of the total value of commodities traded in the island group. Manufactured goods classified chiefly by material ranked second sharing 22.3 percent (PhP22.61 billion). This was followed by machinery and transport equipment with PhP16.13 billion (15.9%) (Table 4).

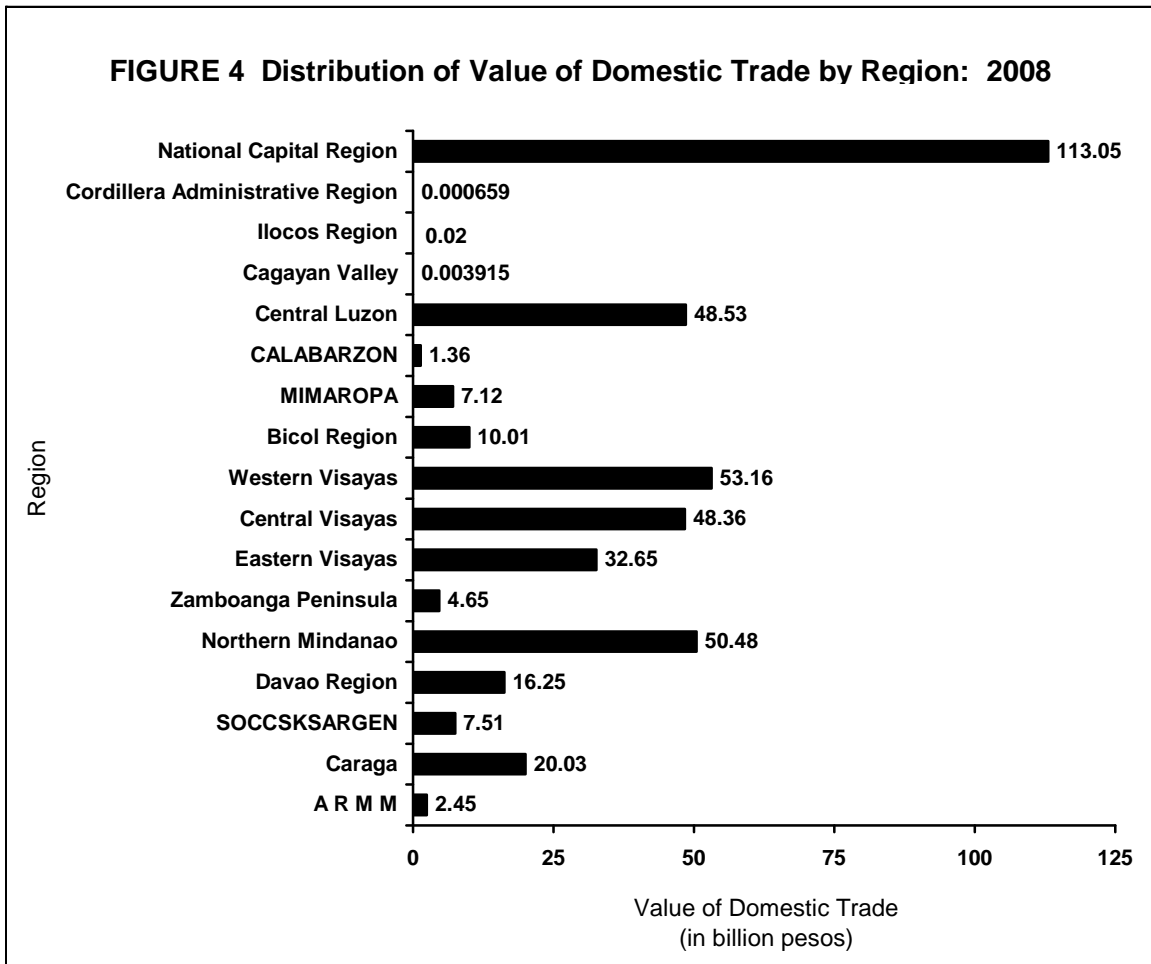




### NCR leads in value of domestic trade

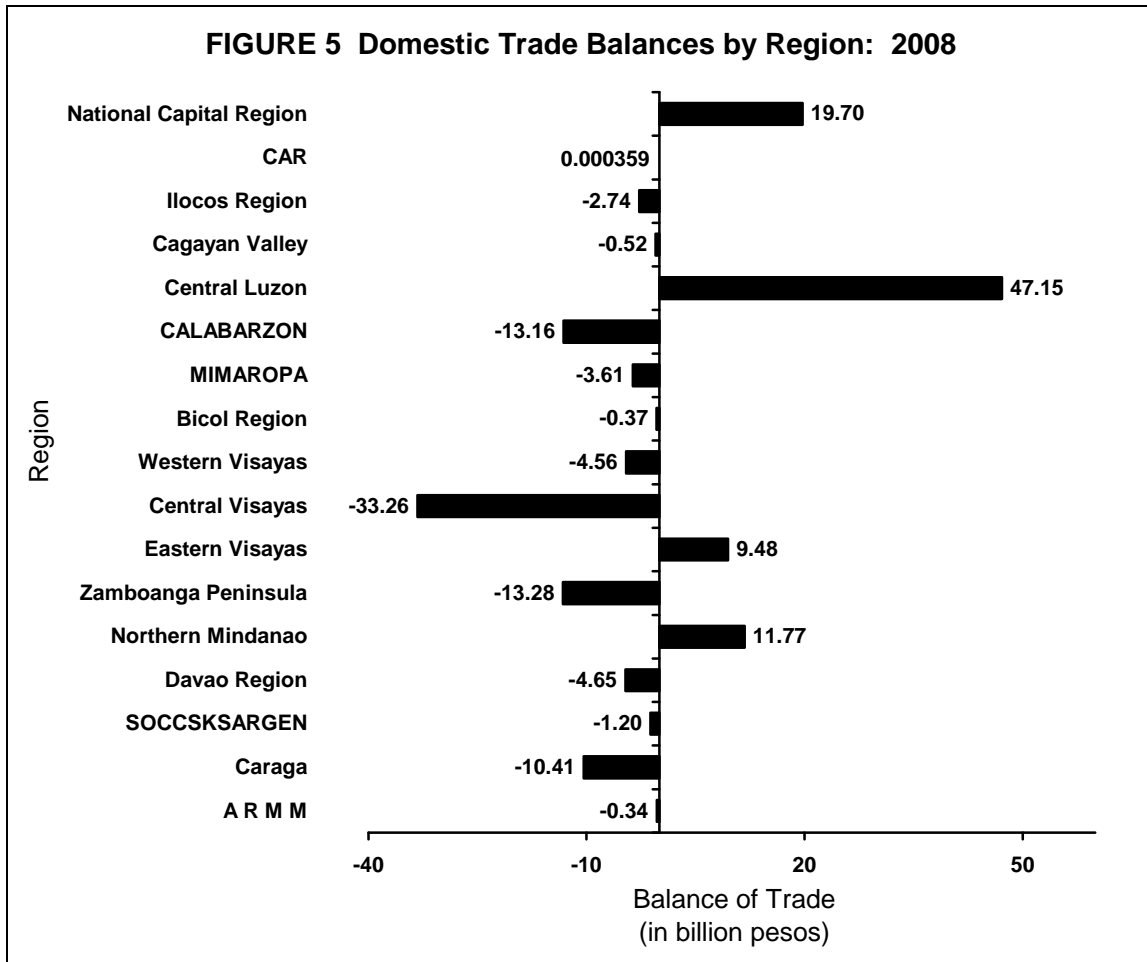
In 2008, the NCR accounted for 27.2 percent (PhP113.05 billion) of the total value of domestic trade, the largest share among the regions. Western Visayas was next with transactions amounting to PhP53.16 billion (12.8%). Northern Mindanao followed closely, contributing PhP50.48 billion (12.1%). Central Luzon was fourth with PhP48.53 billion (11.7%) while Central Visayas was fifth with PhP48.36 (11.6%). Cordillera Administrative Region's domestic trade contributed the least share with only PhP659 thousand (Figure 4).

Of the total value of commodities coming from NCR, the major regions of destination were Western Visayas (PhP32.74 billion), Central Visayas (PhP28.50 billion), Davao Region (PhP15.94 billion) and Northern Mindanao (PhP12.38 billion). Commodities traded from NCR were mostly manufactured goods classified chiefly by material, amounting to PhP30.67 billion (27.1%) (Table C2).



### Central Luzon posts the highest favorable trade balance

Central Luzon recorded the most favorable balance of trade in 2008 at PhP47.15 billion. Other regions which surpassed the billion positive trade balance were NCR (PhP19.70 billion), Northern Mindanao (PhP11.77 billion), and Eastern Visayas (PhP9.48 billion). On the other hand, Central Visayas suffered an unfavorable trade balance of negative PhP33.26 billion (Figure 5).
