SUBJECT

: Non-Issuance of Certificate of Legal Capacity to Israeli Nationals Who Will Marry Filipino Nationals, by the Israeli Embassy in Manila

Please be informed that the Israeli Embassy of Manila is no longer authorized to issue Certificate of Legal Capacity to Israeli nationals who will marry Filipino nationals. This information was conveyed to the NSO-OCRG by the Department of Foreign Affairs (DFA) Manila in its letter dated 28 May 2004 (Annex A). Said information was relayed to DFA by the Israeli Embassy in Manila through its Note Verbale No.23270 dated 01 June 2003 (Annex B).

The following procedures should be followed in the event of a marriage between an Israeli national and a Filipino national.

- 1. The Israeli national shall submit to the Ministry of Interior in Israel a request for status verification;
- 2. The Hebrew written document acquired in (1) should be translated into English by a certified Notary Public;
- 3. The certification of translation together with the document acquired in (2) should be properly authenticated by the following agencies:
 - a. The Ministry of Justice in Israel;
 - b. The Ministry of Interior in Israel; and
 - c. The Philippine Embassy in Israel.

Dear Mrs. Hufana:

This is to inform the NSO-Office of the Civil Registrar General (OCRG) that the Embassy of Israel in Manila is no longer authorized by the competent authorities in Israel to issue Legal Capacity Documents. In the event of marriage between an Israeli national and a Filipino national, the following procedure is to be followed:

- 1. The Israeli national is requested to submit to the Ministry of Interior in Israel a request for status verification certificate.
- The Hebrew written document acquired in (1) should be translated into English by a certified Notary Public.
- 3. The Certification of translation together with the document acquired in (2) should be properly authenticated by the following agencies:
 - a. The Ministry of Justice in Israel
 - b. The Ministry of Interior in Israel and;
 - c. The Philippine Embassy in Israel

The above information was conveyed to the DFA Manila by the Israeli Embassy in the latter's Note Verbale No. 23270 dated 11 June 2003, copy attached. The Department refers the matter to NSO for its appropriate action as it involves an issue in compliance with a formal requirement for the solemnization of marriage.
